2	The Registered offices of the Society shall be situated in the Union Territory of Delhi and at present is C/o ITL Public School, Sector-9, Dwarka, New Delhi-110 077
3	<u>Aims and Objectives</u>
I	To work for the educational uplift of children of all classes/communities irrespective of any distinction or discrimination
II	To start a composite, unaided and co-educational school (Nursery to Class XII) and to start a chain of such educational institutions with a view to improve the society in general.
III	To run general schools and technical/vocational institutions with a view to uplift the social and socio-economic conditions of the financially weaker section in particular and public at large.
IV	To encourage the poorer parents to send their children to school
V	To run free classes for handicapped (men/women) to make them (men/women) self-sufficient and self-reliant.
VI	To assist the authorities of the government and also different voluntary agencies in their educational and literacy programs/classes
VII	To assist the authorities of the government and voluntary agencies in implementation of different schemes for the uplift of the poor.
VIII	To hold classes for useful vocational subjects like crockery, sewing and cutting, tailoring for girls and women.

S.NO.	Description
1	Name: The Name of the Society shall be "Vasudeva Educational Foundation Society".
2	A) MEMBERSHIP Subject to the approval of the society Governing body, any Indian NRI irrespective of caste, colour creed or sex may become a member of the society provided he/she believes in aims and objective of the society
	B) LIFE MEMBERS Any Indian NRI NRI may become a Life Member of the Society on payment of Rs. 2000/- as subscription
3	SUBSCRIPTION The rate of subscription shall for all the members of Rs. 10/- per month. REFUSAL The Governing Body of the society may refuse any persons's membership provided reasons for the refusal shall be communicated to the person concerned. EXPULSION The Governing Body of the society may expel any member from the society on the following grounds:- i) If the member fails to pay the monthly subscription continuously for three month from the due date of paying the subscription. ii) If the member works against the aims and objectives of the society iii) if the members fails to attend three continuous meetings of the General Body/Governing Body. APPEAL The reasons for expulsion shall be communicated to every member. Every expelled member shall have a right to appeal before the general body which may or may not be accepted RE-ADMISSION An expelled member by the Governing Body can be re-admitted provided- i) His / Her appeal has been approved by the General Body ii) He / She has paid all his/her dues

To appoint an auditor who will annual inspect the accounts of the society's funds. <p><u>RIGHTS AND PRIVILEGES OF THE GENERAL BODY MEMBERS</u></p> <p>All and every member of the Society:</p> <ol style="list-style-type: none"> Shall have only one vote at every meeting. Shall be entitled to participate in the meetings and functions of the society. Shall make his/her activities to promote/develop the aims and objects of the society. To elect or contest for the members and office bearers of the Governing Body.

No quorum shall be required in adjourned meetings and emergent meeting on the Governing Body may also be summoned on the written request of 3/5 members.</p> <p>The following business shall be transacted in these meetings:-</p> <ol style="list-style-type: none"> To take necessary steps for the implementation of all the programs and policies drawn by the general body. To pass the necessary expenditure to meet the day to day requirements of the society. To take all such other legal steps which may appear beneficial for the smooth and better management of the society. <p>The following is the present structure of the Governing Body:-</p> <ol style="list-style-type: none"> President Vice – President Secretary Joint Secretary Treasurer Members 6 to 21

6	<u>OFFICE BEARERS AND THEIR DUTIES</u>
a)	<u>President:</u> i) He/She shall preside over all the meetings of General Body and Governing Body. ii) He/She shall supervise work of other office bearers from time to time. iii) In case of equality of votes in any meeting, he/she shall tender his/her casting vote.
b	<u>Secretary</u> i) During the absence of the president, He/she shall take the Chair. ii) He/She shall represent the society in all public and private offices/affairs. iii) He/She shall keep all types of records of the society including the register of member containing therein the names and addresses etc. etc. iv) He/She shall undertake all types of correspondence on behalf of the society. v) He/She shall convene the meetings of general body and shall also inform every members regarding time, date and place of meeting through a ten days earlier written notice.
c	<u>Treasure</u> i) He / She shall collect subscriptions, gifts, donations, grant-in-aid etc. etc. from the members and general public and he/she shall also be responsible and accountable for keeping and maintaining a true and correct accounts of the society's funds. ii) He/She shall supervise audit checks and shall be responsible/accountable for money transactions and audit objects of the society.
7	<u>Financial Years</u> The financial year of the society shall be from 1 st April to 31 st March every year.
8	<u>SOURCE OF INCOME</u> Subscriptions, donations, annual functions, fetes and gifts from the members and the General Public shall be the sources income of the Society. Income from all the sources shall be utilized for the achievement of the aims and objects of the society.
9	<u>BANK ACCOUNT OPERATION</u> The funds of the society shall be kept in Scheduled Bank. The Bank account shall be operated by the President/General Secretary and Treasurer. Once in a year, the books of accounts shall be audited by a qualified auditor appointed by the General Body.




S.NO.	Description
10	<u>ELECTIONS</u> The Governing Body of the society shall be elected for a term of 5 years in the general body meeting. The raising of hands shall be the mode of elections to decide the elected member.
11	<u>ANNUAL LIST</u> Every year, a list of Governing Body office bearers and members shall be filed in the office of the Registrar of Society, Delhi Administration, as required under Section 4 of the Society Registration Act of 1860
12	<u>LEGAL PROCEEDINGS</u> The Society may sue or be sued in the name of its President as required under Section 6 of the Society Registration Act of 1860
13	<u>AMENDMENT</u> Any Amendment in the Memorandum or Rules of this society shall be carried out in accordance with procedure laid down under Section 12 & 12A of the Society Registration Act of 1860
14	<u>DISSOLUTION</u> If the Society need to be dissolved it shall be dissolved as per provision laid down under section 13 & 14 of the Society Registration Act, 1860 as applicable to Union Territory, Delhi
