(without aid) w.e.f. academic session 1988-89 for a
day school.

Sir,

With reference to your application on the subject cited
above, I am directed to grant of recognition to your school
from Class Ist to Xth (without aid) w.e.f. 1988-89 session subject
to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provision of Delhi School
Education Act & Rules, 1973 framed thereunder as well as the
students issued from time to time.
2. That the school shall admit students without any discrimination
staff as per the norms of the department.
3. That the school shall appoint full time qualified and eligible
staff as per the norms of the department.
4. That the school shall equip the science lab. as per the norms
of the deptt. and suitable facilities for practical work
shall be provided to the students. More materials worth
Rs. 5,000/- shall be purchased in during 1988-89 and a list
be furnished to E.O. for verification.
5. That a proper library shall be established and facilities
for reading room shall also be made available for students
as well as teachers. Books as per the ratio of 10 books per
student may be added and facilities of reading room may also
be provided immediately and more books worth Rs. 5000/- be
purchased by the start of next session and the list of books
are furnished to E.O. for verification.
6. That adequate sports materials shall be purchased and made
available to the students immediately.
7. That the school shall strictly abide by the provisions of
NSEA/R, 1973 and payment shall be made as per sec.10(i)
of NSEA, 1973 to all employees.
8. That the enrolment in each section shall not exceed the
number of students calculated @ 12 s.ft. per student for
the available floor area of the class-room and the school
shall provide adequate and sufficient accommodation as per
the norms of the Dept. of Education, Delhi in each class.
Number of the existing sections should not exceed the number
of class-room of proper size in the school.
9. That the school shall dispense with the services of unqualified
& overaged staff, if any, immediately.
10. That the service contract between with the management
and the employees shall be renewed immediately.

11. That all the facilities prescribed under rule 50 & 51 of the DSER, 1973 shall be made available to the students. Provision of rules 6, 7 & 9 be strictly observed.
12. That the arrangement of good drinking water shall be made available to all the students/ teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate to be obtained from the Local Body within a month.
13. That the management of the school shall create a Reserve Fund of Rs. 15,000/- (Rupees fifteen thousand) only in a joint account in the name of the Director of Education and the manager of the school in any scheduled bank within a month.
14. Proof to the effect that the staff has been appointed as per RR's be provided to the E.O. for his verification.
15. Copies of the appointment letters issued to the staff be provided to the E.O. for his verification.
16. Health Certificate be obtained from MCD and be submitted to E.O. within a month, if not obtained earlier.
17. That the violation of any instructions/orders/conditions/rules and regulations of the deptt. shall lead to the withdrawal of recognition of the school and class XI shall not opened without the prior approval of the Director of Education, Delhi.
18. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.
