Subject: Safety & Security of School Children -regarding.

Sir/Madam,

I am to state that Delhi Traffic Police is highly concerned about the safety & security of school children and has raised this issue with the school managements time to time. Hon'ble Supreme Court of India and High Court of Delhi have issued certain directions on this subject which have to be compiled with in respect of the vehicles engaged for transportation of school children. Being a law enforcement agency, Delhi Traffic Police is making its best to enforce these directions meticulously but despite our sincere efforts, some common violations by the School Cabs/vans/Buses can be seen on roads which are as under:-

Hon'ble Court has clearly directed that vehicles engaged for ferrying school children (school buses/cabs/vans) cannot carry school children more than 1 ½ times of the seating capacity of that vehicle in excess of the permitted capacity by putting lives of school children at risk.

Safety norms as directed by the Hon'ble Supreme Court of India are not followed by the vehicles engaged in transportation of school

children.

Private Vans, which are not supposed to be used for ferrying school

children, are engaged for transportation of school children.

School children who are minor are oftenly seen coming to school on Scooty M-cycles etc. putting their lives at risk as well posing danger to other road users whereas they are not supposed to drive such vehicles.
