REOPENING OF SCHOOL FOR CLASSES III to V

Dear Parent,

As per the Directorate of Education circular dated 5/2/2022 (attached as Annexure A), the schools are permitted to reopen for all the classes with effect from 14/02/2022, Monday subject to strict compliance of the COVID SOPs.

Please note the following:

- 1. Attendance for Offline School is completely voluntary and is not compulsory.
- 2. Offline / Online classes will be conducted every-day from 8.30 am 12.45 pm as per the new time-table. The new time table will be shared shortly on the class WhatsApp group.
- 3 Reporting time to school for offline classes is 8:15 am. No school transport will be provided and you shall be required to arrange and manage the transportation of your ward.
- 4 Children will be handed over to the parents at 12:45 pm. Parents are requested to pick up their wards from the school gate only. No parent will be allowed inside the school premises.
- 5. Kindly note that in order to maintain social distancing and effectively implement all COVID-19 related precautions, the school shall follow standard operating guidelines and procedures.
- 6. If the child or any of the family members shows COVID symptoms parents should avoid sending the child to the school.
- 7. Parents are advised not to send their ward to school if he/she is suffering from any critical illness/comorbidity.
- 8. Kindly fill in the attached consent form in Annexure B and send it with your ward on the first day of reopening i.e. 14th Feb 2022. Entry without the consent form will be prohibited.
- 9. Seating plan will be as per capacity/occupancy limit of class following COVID appropriate behaviour.
- 10. Lunch breaks will be staggered to avoid crowding.
- 11. Students will be guided not to share stationery, tiffin etc.
- 12. Students living in containment zones will not be allowed to come to school.

Sub: Reopening of Schools.

The Delhi Disaster Management Authority (DDMA) has allowed the reopening of schools vide order No. F.60/DDMAJCOVID-19/2021N01.-II/518 dated 04.02.2022. Therefore, in pursuance of the DDMA order, all the Govt., Govt. Aided, Unaided Recognized, NDMC, MCDs and Delhi Cantonment Board Schools will reopen with effect from 07.022022 (Monday) for classes IX to XII and from 14.02.2022 (Monday) for all the classes with the parental consent only.

The Heads of Schools shall call the students in such numbers and manner, taking into account the available space / infrastructure / facilities of their schools, so as to ensure that COVID Appropriate Behavior (viz. wearing of mask, maintaining social distancing, regular hand washing and use of sanitizer etc.) is complied with at all times in Schools. The blended/hybrid mode of teaching learning process (online & offline) should be followed till further orders. Accordingly, Heads of all Schools will have to reframe the Time Table and inform the parents & students accordingly.

The school authorities shall make all out efforts to encourage parents of students above 15 years of age to get their wards vaccinated for the 1 $^{st}/2^d$ Covaxin dose as per guidelines.

The guidelines along with the annexed COVID-19 related SOP, Check List for HOS and Parental Consent Form as provided by DDMA vide above mentioned order regarding reopening of schools are to be read most carefully by all the Heads of Schools and followed in letter and spirit (Copy of DDMA order enclosed).

HoSs are also directed to disseminate the above information among all the students, parents, teachers and SMC members.

RDEs/DDEs must visit the schools, esp. on day one of reopening of schools.
