



ADMISSION TO PRE-SCHOOL FOR ECONOMICALLY WEAKER SECTION AND DISADVANTAGED GROUP

Total number of seats for Pre-school for Economically weaker section and Disadvantaged group - 26

Eligibility:

- Age : - Minimum age 3 as on 31st March 2015.
 - Distance (to & fro BPS,C-8,Vasant Kunj) :- As per neighbourhood criteria vide Circular No. F.15(11)DE/ACT/2011/7563-74 dated 13/02/2012:
1. Admission shall first be offered to eligible students belonging to EWS and Disadvantaged Group residing within 1 k.m. of the specific school.
 2. In case the vacancies remain unfilled, students residing within 3 k.m. of the school shall be admitted
 3. If there are still vacancies, then the admission shall be offered to other students residing within 6 k.m. of the institution.
 4. Students residing beyond 6 k.m. shall be admitted only in case vacancies remain unfilled even after considering all the students within 6 k.m. area.

GENERAL INSTRUCTIONS (EWS CATEGORY)

1. In case of incomplete form, incorrect /false information / document, the form will be rejected without any correspondence in this regard.
2. To submit anyone of the following documents as proof:
 - (1) Birth certificate under the Births, Deaths and Marriages Certification Act, 1986.
 - (2) Hospital/Auxiliary Nurse and Midwife (ANM) register record.
 - (3) Anganwadi Record.
 - (4) Declaration of the age of the child by the parent or guardian
 - (1) Ration card issued in the name of parents (mother/father having name of the child).
 - (2) Domicile certificate of child or of his/her parents.
 - (3) Voter I-card of any of the parents
 - (4) Electricity bill/MTNL telephone bill/water bill.
 - (5) Unique Identity Card of mother/father/child issued by Government of India.
 - (6) Passport in the name of any of the parents or child.
 - (1) Income certificate issued by a Revenue Officer not below the rank of Tehsildar.
 - (2) BPL Ration Card (Yellow Coloured)
 - (3) AAY Ration Card (Pink Coloured)
 - (1) A Certificate issued by a Revenue Officer not below the rank of Tehsildar or any other Competent Authority.
 - (2) Cast Certificate issued by DC Office.
 - (3) Medical Certificate from Govt. Hospital, in case of children with special needs/disabilities.
 - (4) A Certificate issued in accordance with instruction issued by the Department of Women and Child Development, GNCT OF Delhi, vide order dated 11.12.12 in case of Orphan Child.

Proof of Disadvantaged Group

- (1) A Certificate issued by a Revenue Officer not below the rank of Tehsildar or any other Competent Authority
 - (2) Caste Certificate issued by DC office.
 - (3) Medical Certificate from Govt. Hospital, in case of children with special needs/disabilities.
3. (a) Parents will certify that all the information provided by them is correct and they understand that if the information is found to be incorrect or false, their ward shall be automatically debarred from selection / admission without any correspondence in this regard.
- (b) Parents also understand that the application / registration / short listing does not guarantee admission to their ward.
- (c) Parents accept the process of admission undertaken by the school and will abide by the decision taken by the school authorities.
