<u>CIRCULAR TO THE PARENTS: TABS: BYJU'S STUDY MATERIALS</u> CLASSES IX TO XII

Dear Parent,

- 1. This school has got limited Byju's tablets for Classes IX to XII with loaded learning materials in Science, Mathematics and Commerce for students. Now as per direction from CMC's office (Air HQ/CMC/2/Gen dated 21 Dec 20), the same is required to be issued to students from Classes IX to XII. These tablets are exclusively contained with BYJU'S learning materials only. Students cannot use these tablets for any non-educational purpose (for example, browsing the Internet or making phone calls). This will avoid distractions and keep the devices free of malware.
- 2. After having done BOC-action, all received tablets will be issued by the Librarian to the first ten roll numbers of all sections of Classes IX, X, XI & XII for a period of 15 days and then it will be returned to the school Library by the students and the same would be reissued to next ten roll (11-20) numbers for the next 15 days and would continue in the same fashion. The students who are interested to avail the facility can send the request form (scanned copy) by email at srlibtafs@gmail.com so that necessary arrangements for entry and exit can be done at the Subroto Park entry. The students are required to use and return it in serviceable condition within defined time otherwise a late fee of Rs.100/- per day will be charged (through fee slips). It would be responsibility of the student and his parent to return the tab in perfect condition.
- 3. The students must adhere to the following COVID-19 guidelines.
 - (i) Students should come in school uniform.
 - (ii) Use of face covers/masks.
 - (iii) Physical distancing of at least 6'.
 - (iv) Respiratory etiquettes to be strictly followed.
 - (v) Only asymptomatic children would be allowed in Subroto Park Camp/School premises
 - (vi) Students would undergo thermal screening, hand hygiene at entry point of the school.
- 4. The distribution plan is annexed. Parents are requested to adhere to the distribution schedule.
