CIRCULAR TO PARENTS (IX-XII)

**Partial Reopening of schools for students of 9-12th classes
on voluntary basis for taking guidance from teachers**

Dear Parents,

1. As per the SOP dated 08 Sep 2020 issued by Dte Gen of Health Services (EMR Division), Ministry of Health & Family Welfare, Govt. of India and as per the direction received vide Air HQ/CMC/2/Gen dated 10 Sep 20, school is planning to reopen partially for students of classes 9-12th on voluntary basis for taking guidance from their teachers.
2. The school is taking all the required precautionary measures to ensure safety of students & teachers in the present scenario of the epidemic.
3. Following points are required to be taken into account to facilitate safe & smooth partial reopening of the school:-
 - (a) School transports would not be plying on the road in present epidemic condition to ensure students' safety. Concerned/volunteer parents may make their own arrangements to drop & pick-up their wards from the school. Schedule of drop/picking up by the parents would be informed shortly.
 - (b) Students are supposed to be with Arogya Setu App in their mobiles.
 - (c) Students must follow the following inescapable points:-
 - (i) Use of face covers/masks.
 - (ii) Physical distancing of at least 6'.
 - (iii) Respiratory etiquettes to be strictly followed.
 - (iv) Self monitoring of health and reporting any illness at the earliest. Only asymptomatic one would be allowed.
 - (v) Students belonging to containment zone - not allowed.
 - (vi) Cafeteria/Sports Fields not to be visited.
 - (vii) Students would undergo thermal screening, hand hygiene at entry point of the school.
 - (viii) Students not to be allowed for sharing of items notebook, pens etc.
 - (ix) Students do not gather when leaving the school/during free time. If someone is sick, need not to come to the school & to follow necessary protocols.
 - (d) If you are volunteer & willing to send your ward, the consent form, as hereunder, is to be filled-up & sent to the school latest by 15 Sep 20 (by email at tafsdelhi@gmail.com) for our further actions/necessary arrangements.
