### Rules & Regulations

- Fee is to be paid quarterly along with the tuition fee.
- Transport fee will be charged for 11 months only.
- Children will be handed over to the parent/person having the attendant card issued by school authority, otherwise the child will be brought back to school and will have to be picked up from school by the parent/authorized person.
- Kindly inform the school about the change of address and contact no. immediately to avoid inconvenience.
- No request for the change of bus stop for emergency dropping of the child will be entertained.
- Bus facility will be withdrawn from the student if found indulging in any in-disciplinary activity while travelling in the school bus.
- The bus will ply only as per approved routes.
- The bus will halt only as per the stops allotted to a particular bus route, no other change in stops will be considered once they have been allotted by the school. The minimum students for each stop will be five (5) & the minimum distance between each stop will be 100 meters.
- Students not in time for the bus will have to make their own arrangement on that day to come to school.
- Students who are not regular in paying bus fees and cause trouble will not be allowed to use the bus services.
- Bus fees once paid will not be refunded under any circumstances.
- The bus fee is subject to increase if there is a hike in taxes, price of spare parts, hardware, fuel, contract charges and maintenance charges and staff salaries.
- In the event a student does not return home on time after being handed over to the escort at the specified bus stop the school/bus authorities will not be held responsible for the same.
- No parent will be allowed to travel by the school bus. It is strictly for the use of school students in uniform only.
- In the event of any change in person who will be responsible to pick up a student the same has to be informed to the bus in charge.
- Parents are requested not to handover school fee to any employee of the school, if they do so the school authority will not be responsible.
- Parents are requested to ensure that they send only regular and approved representatives to pick and drop their child/children at the designated stop.
- In case of discontinuation of the bus services by student the bus card is to be returned to the school. The student will also be liable to pay the transport fees for the remaining period of the academic session.
- Transport facility cannot be withdrawn after once taken. The fee for the entire session has to be paid.
