Technology Enabled Education

3. Digital tools such as Kahoot, Book Creator, Edpuzzle, Wakelet, Canva, Padlet etc.
4. Open source platforms such as Diksha (Digital infrastructure for knowledge sharing), NROER (National Repository of Open Educational Resources) etc.
5. Digital content has been created by teachers to support Synchronous and Asynchronous learning.
6. Other resources such as Youtube, Google earth, TEDx and TedEd videos etc.

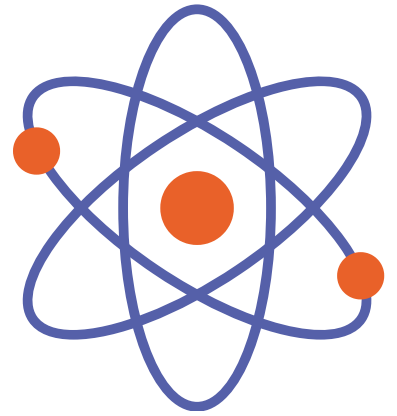
Bloom's Taxonomy

Ensure there is no background noise/ distractions

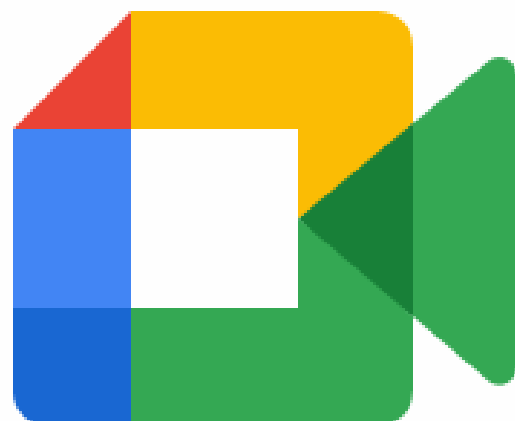
Child should be appropriately dressed

RULES AND REGULATIONS

The decision of the Principal, on R & R not covered herein, will be final

I. ATTENDANCE

Leave of more than two days a formal application is required is to be sent to school principal and class teacher or can be communicated on PT Communication through Cloud 9.

It is to be noted that the students of Classes X and XII are eligible to appear for the CBSE Board examination only if they have the requisite attendance as per the CBSE Examination Bye-Laws www.cbse.nic.in. available on the CBSE website.

II. FEE

The School follows a monthly billing cycle.

Fee bills are uploaded on the Parent Portal on the 1st of every month. Details of last date of payment of fees without fine, are mentioned in the fee bill.

Fee is required to be paid for all the twelve months of the year.

School fees will either be accepted through online payment (Net Banking, Paytm etc.) or by Cheque/Bank Draft at school fee counter. Cash will not be accepted.

Bounced cheques returned by the bank to the School will be dealt with as per applicable laws.

In case of delay in fee payment/ non-payment of fee, the School may take appropriate action as per applicable laws.

III. SECURITY DEPOSIT

The security deposited at the time of admission is refundable only if the student clears all the fee and transport dues at the time of withdrawal.

IV. WITHDRAWAL

For any withdrawal from the school, at least one month's notice is required, failing which, fee of the additional month will be charged from the student concerned.

For Government Employees, request for waiver of notice period fee, can only be made on submission of transfer order with instructions of immediate transfer.
