Sir,

This is with reference to your application dated 7.6.2002 to establish a new school under Rule 44 of D.S.E.A. & Rules, 1973. I am directed to state that the appropriate authority after considering the particulars specified in the application form has accepted the proposal to establish a new school from class I to Sec. in Zone No. XXII of Distt. South West-B

2. The said acceptance to establish new school in Zone No. 22 of Distt. SW-B shall be limited only for a period of 05(five) years. Please note that no extension to this limit of 05 (five) years would be granted under any circumstances.

3. The acceptance to establish new school will automatically lapse, if the Society/Trust fails to obtain recognition from the appropriate authority after fulfilling the conditions of recognition as laid down in Rules 50 and 51 of D.S.E.A. & Rules, 1973 and sub-section (1) of Section 4 of D.S.E.A. & rules, 1973 within a period of FIVE years.

4. Standard preliminary norms for recognition of the school are enclosed for favour of your appraisal and guidance.

5. This is issued subject to the condition that the school will follow the directions of department on fee structure etc.

6. As indicated by you in your EC application, you would not be requesting for sponsorship of land at any stage.
